We confirm, that the inks listed mentioned above in compliance with the *EuPIA EXCLUSION POLICY FOR PRINTING INKS AND RELATED PRODUCTS*.

They are formulated following the *EuPIA Guideline on Printing Inks applied to the non-food contact surface of food packaging materials and articles*.

The possibility of compliance with *European regulation 1935/2004* using the above named inks is confirmed in the "Statement of composition" which is available on demand.

They are formulated in compliance with regulations *PIM 10/2011 and EC 1282/2011*.

In the *European regulation 2023(2006)* good manufacturing rules for materials and objects, which are determined to come into contact with food are obtained. General rules for all deliverers in the value creation chain are defined and stated, that a quality assurance system with corresponding controls and documentations are present. Additionally a sufficient documentation is essential.

Our above named printing inks allow to be compliant with this requirements, respectively these rules have been maintained during the production of these inks.

The inks are developed for printing the outside of packagings with no functional barrier. They are not suitable for direct food contact.
